B. PROJECT DESCRIPTION

1. TYPE OF PROJECT

With powerful genetic and ethnic codes in its arsenal, Ukraine is already perceived in the world community as a multi-vector and competitive state capable of exporting its potential, forming strategic vectors of its own state and nation-building.

The task facing our society today is to strengthen the international dimension of the Ukrainian humanitarian sphere which is reflected primarily in cultural, educational, scientific, artistic and sociopolitical programs.

Establishing a platform for the integration of higher education into the European and global space, Ukraine has opened wide opportunities for the implementation of not only educational, scientific, cultural, but also governmental projects. The goals and objectives set by the strategies of the Ministry of Education and Science of Ukraine, the Ministry of Culture and Information Policy of Ukraine, the development strategy of the Ukrainian State Center for International Education

and the UNESCO medium-term program are aimed at achieving high quality education, competitive in modern environment. An important place in such program is occupied by UNESCO Chairs as an official participants of the program "UNITWIN / UNESCO Chair" in Ukraine which are open in leading institutions of higher education in Ukraine and around the world.

The Ukrainian National Tchaikovsky Academy of Music is an important center of art education which is formed on the basis of classical academic education. The NMAU as an absolute subject of art education in Ukraine, a center of scientific achievements and cultural achievements, holding a leading place in world culture and education society, starts the work of the "UNESCO Chair on Music, Education, Science - for Peace".

Tasks of the UNESCO "UNESCO Chair on Music, Education, Science - for Peace" are determined by the processes of cultural creation of the XXI century, which are marked by a certain unification, represented by elements of powerful globalization as a condition, as factor of multiplicity in all its manifestations and alterglobalization with its active movement for justice and the idea of equality. - implementation of the project "Artistic Message" - the anthem "Tree of Peace";

- continuation of the artistic project "Art against the pandemic" with the participation of UNESCO artists from around the world (France, Mauritius, Turkey, Japan, Georgia, South Korea, Niger);

- implementation of the action "Musical gratitude to doctors "For the sake of life", which is held under the auspices of UNESCO and with the support of the WHO;

- holding together with the UN Office in Ukraine cultural and artistic events dedicated to the preservation of the environment: "Music of all continents", "Music for Peace".

Cooperation with leading higher education institutions under the Erasmus+ International Academic Mobility Program is planned in order to expand the scope of partnership and to strengthen the educational environment in terms of integrating the Academy's educational programs into the European space.

4. GOALS

Objective: to promote sustainable and harmonious development of society through the establishment of an integrated system of education, science and art in order to

preserve cultural values, ensure cultural development, freedom of creativity, freedom of speech, free access to education and information.

Specific goals

The work of the "UNESCO Chair on Music, Education, Science - for Peace" at the NMAU is aimed at a clear implementation of the global goals of sustainable development 2015-2030. By implementing the UNESCO program in the educational environment, the NMAU will be the subject of both governmental initiatives and global challenges.

The tasks of the department in the field of culture are:

1. Observance and implementation of the 1970 Convention, the main purpose of which is to recognize the universality of culture.

Implementation mechanisms:

- fight against theft and illicit trafficking of cultural property;

- universalization of culture;

- protection and development of various forms of cultural self-expression;

- formation of audiovisual archives as an opportunity to learn about the cultures of the world.

- support for the anti-apartheid program in South Africa;
- emphasize the influence of African culture on European and world;
- combating racism and racist behavior;
- combating inequality between ethnic groups;
- fight against social conflicts;

- support of the program of vaccination of the population in the system of education, culture, art;

- support for the refugee protection program;
- support for low-income groups.

The implementation of the program "Overcoming Poverty", "Overcoming Hunger", "Decent Work and Economic Growth" is possible if UNTAM is involved in the presentation of education, science and art as the most effective tools to combat poverty around the world.

Implementation mechanisms:

- holding Flash Mobs to support the poor;
- initiating and joining volunteer movements;
- involvement of commercial leaders in order to provide charitable support to the population in need of support.

The NMAU will have the opportunity to actively integrate its own educational programs and models into the international environment encouraging the cooperation between leading institutions not only in Ukraine but also in Europe.

4. Transfer of knowledge

The UNESCO Chair has a great responsibility, which involves the accumulation of valuable experience in the system of higher art education, which is formed on the strong traditions of professional, academic, classical continuing national education. Through the accumulation of experience, in the process of practical training, students

of NMAU will receive quality, modern and based on contemporary demands education, and even more - experience and a set of professional competencies focused on international educational practices.

9. PROPOSED SCHEDULE OF MAIN ACTIVITIES

Schedules for the implementation of cultural, artistic, educational and scientific projects will be formed, agreed and published after passing all the necessary procedures.
